GUIDELINES

The event complies with the ESF Junior Circuit Guidelines, a copy of which is available on the ESF website – www.europeansquash.com – all participants should make sure that all relevant people (including coaches, managers and players) are aware of the Guidelines and their requirements.

Categories

The following maximum number of players will be accepted in each category:

BU 13	Max. 16 playesr
BU 15	Max. 32 playesr
BU 17	Max. 32 playesr
BU 19	Max. 16 playesr

GU 11	Max. 16 playesr
GU 13	Max. 16 playesr

GU 19	Max. 16 playesr

Players may only enter one category. All players are guaranteed a minimum of 3 matches. **Please note that U11 categories are not recognised for ranking purposes of ESF.**

Eligibility

The Luxembourg Junior Open is open to all players under the age of 11, 13, 15, 17 and 19 on 12 April 2024 as appropriate.

Seeding

The seeding will be carried out using the ESF Junior Rankings valid at the closing date and in accordance with the ESF Junior Circuit Guidelines. Any non-European players who do not have an ESF ranking will be seeded by the Tournament Director. Details of the seeding will be found on the tournament website (www.ljopen.lu).

Matches & scoring

All matches will be played as best of five games, under the rules of the WSF. PAR scoring to 11 will be used at all tournaments on the ESF Junior Circuit (to 2 clear points). All game scores will be reported in full.

Refereeing

All players will be expected to mark and referee matches. **This will happen together with your opponent from the last match!**

Ball

The Dunlop Pro ball will be used.

Prizes

There will be prize money in the U19 categories and trophies in all other categories.

Insurance

Players enter and play in the tournament at their own risk. Neither the organisers nor the ESF accept any responsibility for injury arising from participating in the event. Players must arrange their own insurance. All players have to wear approved protective eye guards on court.

Entries

Players should register online at Luxembourg Junior Open 2024. Link to the registration page is also available on the www.ljopen.lu website. The LJO team can be contacted via that website or the email address ljopen2024@gmail.com

All entries must be made through or endorsed by the relevant national or provincial federation. Any entry not endorsed by a player's federation will not be accepted.

All entries will be acknowledged upon reception. **Entry is considered valid once payment is received.**

Draws

The seeding and times of the first matches will be published in the tournament website. The finalised draws will be published at the venue at the start of the event.

Draws will be circulated to all individual players by e-mail. Times of first matches will be indicated for their players.

All players will be guaranteed a minimum of three matches.

Safeguarding, health and safety

Adults interacting with juniors in the organisation and running of ESF Junior Circuit events are in a position of trust and influence. They should always ensure that junior players are treated with integrity and respect. Tournaments should be run in a safe, positive and encouraging atmosphere. The Tournament Director and Tournament Referee should be trained in safeguarding children according to the host MNF national standards for child protection.

The health and safety of all persons (players, officials, spectators, tournament staff) involved in or attending a tournament is of paramount importance. The host MNF is responsible for ensuring an appropriate plan is in place for the tournament.

Privacy Policy

The tournament will be run under the terms and conditions as set out in ESF Regulations: Code of Conduct - The tournament will be run under the terms and conditions as set out in EUROPEAN SQUASH FEDERATION PRIVACY POLICY as published on the ESF website www.europeansquash.com

European Squash ID (ESID)

All players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported.

Coaches

All team or individual player coaches designated by their nation as part of their event onsite management team (solely, or in attendance with an appointed team manager) at any Championship held under the auspices of ESF must be ESF Registered i.e. have a ESF European Squash ID as their licence to attend in a formal representative role. This is required at the time of them being registered to attend by their national federation

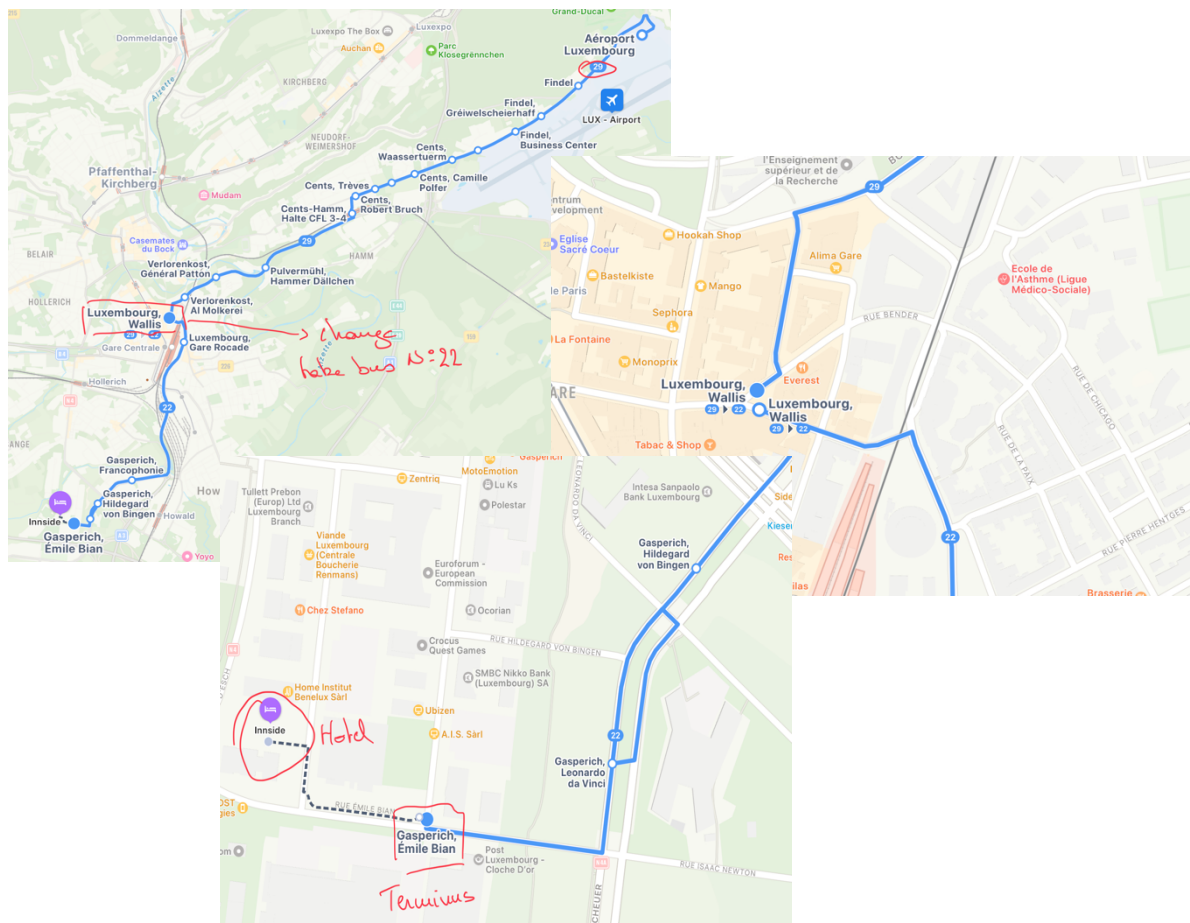

a. From Airport to Hotel:

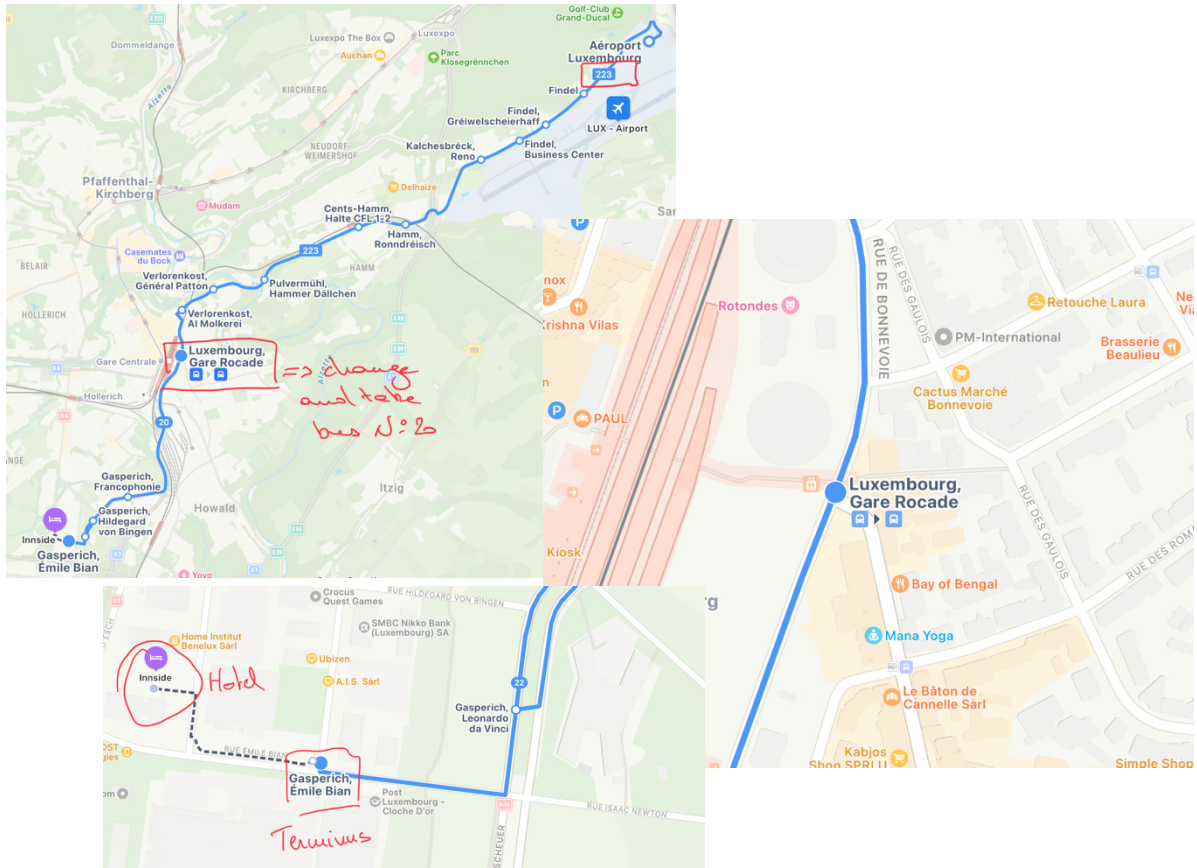
Estimated time: 30 - 40min

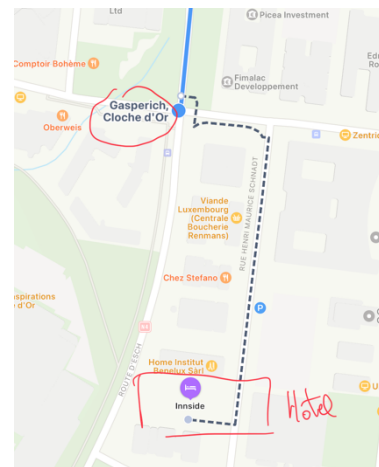
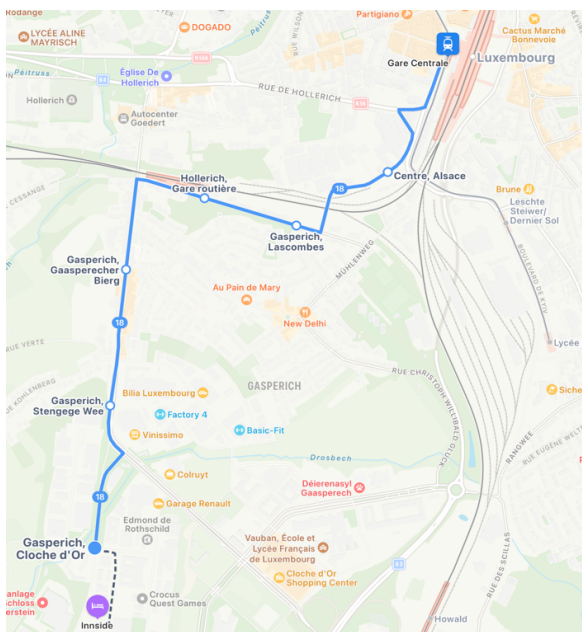
At the airport take bus N°223 and change at "Luxembourg Gare Rocade" for the bus N°22



b. From Train Station:

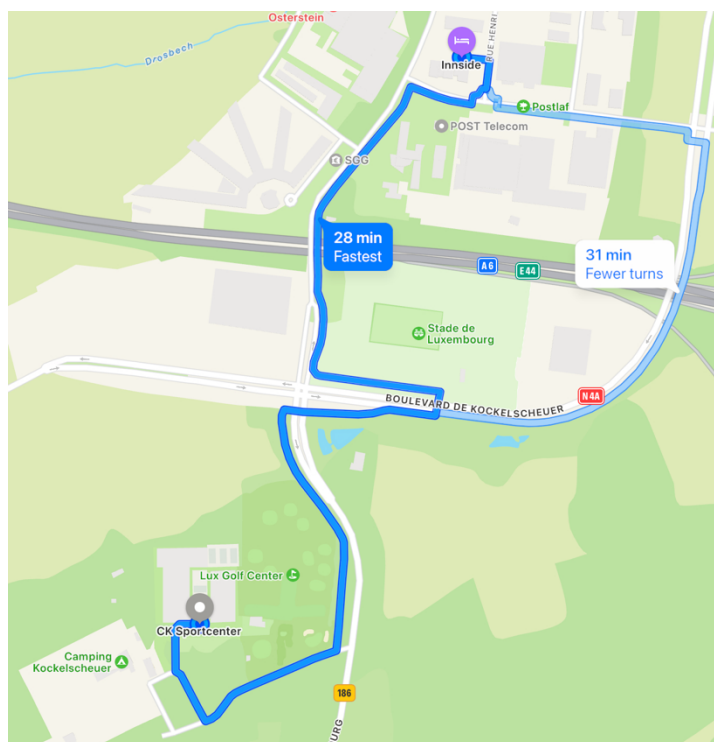
Estimated time: 20min

Eye Guards

All competitors at ESF approved junior tournaments must wear approved protective eye guards, manufactured to an appropriate national safety standard, properly over the eyes at all times during practice and competition play. This includes the knock-up.

It is the responsibility of the player to ensure that the quality of the product is satisfactory for the purpose. Players will not be allowed to compete without this protection. The list of WSF certified eyewear, allowable at the time of participation, can be viewed on the WSF website <http://www.worldsquash.org>

Filming /Photography

Recording of matches for coaching/performance analysis purposes is acceptable provided the players &/or their parents/coaches do not object.

Visa Application

If players need to apply for a visa they need an invitation letter from the Luxembourg Junior Open. Players can acquire an invitation letter on request.

ESF regulations & penalties

The tournament is part of the ESF Junior Circuit and will be run in accordance with the ESF Junior Guidelines, a copy of which is available on the ESF website www.europeansquash.com. MNAs should

make sure that all relevant people (including coaches, managers and players) are aware of the Guidelines and their requirements.

The following penalties will apply, in accordance with the ESF Junior Guidelines, Section E.4.a, E.4.b& E.4.c:

E.4.a) If a player makes a late withdrawal from a tournament (2 days or less before the start date), a doctor's certificate confirming injury/illness must be provided to avoid penalties. The medical certificate (with a translation in English) must clearly state the player's name, date of birth and the nature of the illness/injury; the certificate must cover the date of the relevant tournament and must be sent to the ESF office within two days after the final day of the tournament (email: esf@europeansquash.com; fax +44 1424 774879). Any player making a late withdrawal not supported by a medical certificate will receive zero points for the tournament, which will count as one of their 4 best results for the rolling 12 months period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically unless the ESF office receives a doctor's certificate within two days of the final day of the tournament.

If a player commits this offence for a second time within a 12 months period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.

E.4.b) If a player has entered a tournament and fails to turn up, he/she will receive zero ranking points for the tournament. These zero points will count as one of the player's 4 best results for the rolling 12 months period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically.

If a player commits this offence for a second time within a 12 months period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.

E.4.c) If a player fails to play out all scheduled matches for any reason other than illness or injury, he/she will receive zero ranking points for the tournament. Illness or injury must be verified by the tournament director and, if possible, by medical certificate sent to the ESF office within two days of the final day of the tournament. If zero points are awarded, the points will count as one of the player's 4 best results for the rolling 12 months period and will be taken into account when dividing the points to obtain the ranking average. This penalty will be applied automatically.

If a player commits this offence for a second time within a 12 months period, he/she will be banned from the ESF Junior Circuit for a period of 12 months.
